In order to fulfill its mission, annual commitments are made to hire teachers, maintain and update facilities, and purchase curriculum, supplies and equipment. These costs to the school do not decrease when a child is withdrawn. Therefore, Ambleside School of Fredericksburg has a strict NO REFUND, NO WAIVER policy for tuition and fees.
